**SPECIAL CONSIDERATION FOR FINANCIAL INCENTIVES**

Iowa Department of Agriculture & Land Stewardship

General: All programs are subject to requirements contained in Chapter 161A, Iowa Code, and Division of Soil Conservation rules of Section 27, Iowa Administrative Code. Different agreement and consideration will be required prior to reimbursing the applicant depending upon which practice is implemented. PLEASE READ the section related to practice for which you are applying on Form IP-1.

---

**Permanent Practices:** Refer to Division of Soil Conservation rules in Section 27 of the Iowa Administrative Code, Chapter 10 [10.82(3)], Chapter 12 [12.72, 12.73, and 12.82], and Chapter 13 [13.72].

1. Sign a ten- (10-) or twenty- (20-) year Maintenance Agreement (IP-4). Copies of this agreement are available from the soil conservation district office. The agreement contains the following requirements:
    - a. Applicant or successors will maintain the erosion control capabilities of the practice.
    - b. Approval of the soil conservation district commissioners is required prior to removal, alterations or modification of the practice.
    - c. Applicant or successors will notify any prospective purchaser of this agreement.
    - d. Failure to follow the conditions of the Maintenance Agreement will require the applicant or successors to maintain, repair or reconstruct the practice at his/her own expense.
  2. Certify the actual cost of the project.
  3. Sign a receipt of warrant.

**Temporary Practices:** Contouring, Contour Stripcropping, Critical Area Planting, Field Border, Filter Strips

1. Sign a five- (5-) year Performance Agreement (IP-4).
    - a. Applicant or successors will continue practices for length of agreement.
    - b. The recipient shall be allowed to work out a subagreement to transfer the performance agreement to a new landowner or farm operator who agrees to continue to implement the practices during the remaining time period of the agreement..
    - c. Failure to comply will require applicant to repay money provided to them as a result of this agreement.
  2. Sign a receipt of warrant.

### **Conservation Cover**

If a tract of agricultural land has not been plowed or used for growing row crop at any time in the period from 1966 to 1981, it is classified as agricultural land under conservation cover. If that tract is plowed or used for growing row crop, the state financial incentive rate will be limited to one-half (1/2) the otherwise applicable rate. An applicant who knowingly makes a false statement of material facts in signing Form IP-1 commits a simple misdemeanor and, in addition to the penalty prescribed therefor by law, shall repay the Division of Soil Conservation any financial incentive funds obtained in reliance on the false statement.

### **Contract Sales**
